#### I. Job Summary

Under the general direction of the Director of Sports Medicine and Therapy Services, the COA Athletic Trainer works to prevent, assess, treat, and rehab musculoskeletal injuries. In collaboration with physicians, coaches, mid-level providers, and therapists, Athletics Trainers also provide a vital role as a liaison between the practice, students, parents, and assigned school.

Trainers will strive to continually improve patient satisfaction and exceed expectations for service.

#### II. Essential Job Responsibilities

Develop and implement comprehensive programs to prevent injury and illness among athletes in collaboration with Board Certified Sports Therapist.

Apply and teach athletes the use of protective or injury- preventive devices such as tape, bandages, and braces.

Recognize and evaluate injuries; refer to physician as appropriate.

Administer first aid or emergency care.

Manage rehabilitation programs for injured athletes in conjunction with COA's therapy services.

Facilitates sports physicals with physicians and mid-level providers as needed.

Assists with Sports Medicine Symposiums as needed.

Perform administrative tasks such as education, injury, and treatment program logs.

Participates in biannual meetings with school and medical director to review educations programs content on injury prevention, injury logs, protocols and outcomes.

Maintains good collaborative working relationship and communications with multidisciplinary team including coaches, physicians, therapists, mid-level providers, and medical assistants.

Attends staff meetings and provides constructive ideas to improve quality of treatment, patient education, and efficiency of clinic.

Maintains certification.

Complies with all applicable state and federal regulations.
